## **GP's Vote For The Work Capability Assessments (ATOS) To Stop**

At their Conference in May GPs voted for the end of the Work Capability Assessment.

The doctors think there needs to be a better kind of assessment.

Doctors think the assessment needs to look at what people who are disabled or ill for a long time need.

The words the conference agreed are:

That conference, in respect of Work Capability Assessments (WCA) as performed by ATOS Healthcare, believes that the:

• inadequate computer based assessments that are used have little regard to the nature or complexity of the needs of long term sick and disabled persons

• WCA should end with immediate effect and be replaced with a rigorous and safe system that does not cause avoidable harm to some of the weakest and most vulnerable in society.

# Age discrimination against NHS patients is to be made illegal.

From October it will be illegal for doctors or hospitals to refuse to give treatment or medicine to people because of their age.

Some reports say that doctors discriminate against elderly patients when deciding to give treatments or not to give treatments.

To discriminate means to give differently or less than another person. For example, give someone less because they are older.

Care Minister Paul Burstow said: "We know that older people are not always treated with the dignity and respect they deserve because of ageist attitudes - this will not be tolerated... The challenge for the NHS is to look beyond a person's date of birth and meet the needs of older people as individuals."

## **Stopping A Persons Right To Communication.**

GMCDP has been supporting a group of young people to set up as a campaigning group. The group is working on the right to communication. The group do not use speech to communicate (To communicate means to say what you want to say. It may be a different way than talking to people.).

People in the group use facilitated communication. Facilitated Communication means using a piece of equipment to communicate.

The group is called Quiet Riot.

A member of the group has told GMCDP about one of their worries.

The International Society for Augmentative and Alternative Communication (ISAAC) has its annual conference in Pittsburgh at the end of July 2012. People at the conference plan to say they do not agree with facilitated communication.

ISAAC has set up a group to look at (review) using facilitated communication.

The Chairperson of the committee does not like (is openly hostile to) facilitated communication.

There are many members of ISAAC who are worried about the review.

One reason is because they are only looking at research written in English. But there is international research supporting facilitated communication. Disabled people and their supporters are worried about what will happen after this review.

What right does any individual or organisation have to ban what a person uses to communicate with?

The following people will talk to the inquiry:

- People who have been given the label 'schizophrenia' or other labels like 'psychosis'.
- Their families/friends/carers.
- People who use these labels to describe mental health problems in other people,
- People who have concerns about these words (labels) being used.

The people doing the inquiry will write a report. The report will be sent to the Royal College of Psychiatrists and other organisations.

It is about the experiences of disabled workers, disabled job seekers and employers.

The report, 'A Perfect Partnership', found that:

• Sometimes employers are confused by what disability means, who is disabled and what reasonable adjustments are.

• Disabled people do not want to be singled out. They are looking for general ways for people to be supported to do their job. They do not want ways of support that only look at one person.

• The employer and worker working together is the best way to make things right.
