## **GP's Vote For Immediate End To Work Capability Assessment** (ATOS)

GPs at their Annual Conference in May voted in favour of a motion calling for the end of the Work Capability Assessment. The doctors, who represent GPs from across the UK, agreed that the system should be replaced with a more rigorous and safe process which takes into account the needs of long term sick and disabled patients.

The motion that was passed is as follows:

That conference, in respect of Work Capability Assessments (WCA) as performed by ATOS Healthcare, believes that the:

- inadequate computer based assessments that are used have little regard to the nature or complexity of the needs of long term sick and disabled persons
- WCA should end with immediate effect and be replaced with a rigorous and safe system that does not cause avoidable harm to some of the weakest and most vulnerable in society.

## Age discrimination against NHS patients is to be made illegal.

Ministers have confirmed that denying drugs or treatments on the grounds of age will be outlawed from October. The ban will apply to Britain but not Northern Ireland.

There have been a number of reports that suggest that doctors discriminate against elderly patients in the allocation of treatments.

Care Minister Paul Burstow said: "We know that older people are not always treated with the dignity and respect they deserve because of ageist attitudes - this will not be tolerated. Our population is ageing as more of us live longer. The challenge for the NHS is to look beyond a person's date of birth and meet the needs of older people as individuals."

## **Denying A Persons Right To Communication.**

GMCDP have been supporting a group of young people to establish themselves as a campaigning group. This group of nine people joined together two years ago and is focused on the right to communication. The group do not use speech as their primary means of communication but use a method called facilitated communication. The group is called Quiet Riot. A member of this group has raised the following concern.

The International Society for Augmentative and Alternative Communication (ISAAC) has its annual conference in Pittsburgh at the end of July 2012 and at the conference there is a plan to agree a position against facilitated communication.

ISAAC has formed an Ad Hoc Committee to review the use of facilitated communication. The committees chair is openly hostile to facilitated communication.

There are many members of ISAAC who are concerned about the narrow focus of the review, for example they are only accepting research that is written in English, despite the international research supporting facilitated communication.

Disabled people and their allies will be concerned about the wider and more serious implications for this review by ISACC: What right does any individual or organisation have to effectively ban the use of a persons means of communication.

#### **Tameside CAB's New Service**

Tameside Citizen Advice Bureau has received a grant for a 12 month service providing independent advocacy to people aged 60 and over who live in the community and are receiving complex health and or social care provision to enable them to continue living in their own home.

## Inquiry Into The 'Schizophrenia' Label

The Inquiry into the 'Schizophrenia' Label (ISL) is an independent inquiry into the usefulness of 'schizophrenia' as a diagnosis and medical condition. It is also investigating the impact this diagnosis has on people's lives. ISL is supported by national and international organisations, groups and individuals.

An independent panel will examine evidence from people who have been affected by the label of 'schizophrenia' (or similar labels such as 'psychosis'), including those who use or have used mental health services, their families/friends/carers, those who use these labels to describe mental health problems in other people, and those who have concerns about the use of such labels. The panel will produce a report based on this evidence which will be forwarded to a range of organisations including the Royal College of Psychiatrists.

## Liberating The NHS: No Decision About Me, Without Me Consultation

This consultation document sets out the Department of Health's (DoH) final policy proposals which aim to give patients greater choice and control. A number of focused consultation questions seek views on whether DoH have identified the right areas for making sure the NHS empowers patients and service users and delivers real choice across most NHS services.

This consultation document sets out detailed proposals to achieve this. It follows on from the earlier Liberating the NHS.

## Over- looked Communities, Over - due Change

This report which has been produced by the Equalities National Council and Scope presents new, wide-ranging evidence about disabled people from black and minority ethnic (BME) backgrounds and recommends how policy-makers, local authority commissioners, and service providers can improve BME disabled people's access to services.

It highlights the fact that there are at least one million disabled people from black and minority ethnic backgrounds in the UK and that many of them are unable to access the services they need.

## **A Perfect Partnership**

The Equality and Human Rights Commission has published a report that reviews the experiences of disabled workers, disabled job seekers and employers.

The report 'A Perfect Partnership' found that:

- Employers are sometimes confused by what exactly the concept of disability covers, who is disabled and what reasonable adjustments are.
- Disabled people do not want to be singled out and are looking for company-wide solutions to support people to do their jobs effectively.
- A collaborative approach that works for both the employer and disabled worker is the key to success.
