

## **Cabbie Could Lose His Licence**

A cabbie could lose his taxi licence after refusing to take Brian Gaskell



because he was a wheelchair user. Brian was able to get in the taxi behind but took the details of the cab and complained to Manchester council.

The driver was found guilty of a 'refusal to hire' charge at Manchester magistrates court and was fined £100 and ordered to pay £350 costs plus a £15 victim surcharge. He will also have to attend a licensing review hearing where he could lose his licence.

Councillor Nigel Murphy, executive member for the environment, said:

"Every licensed black cab operating in Manchester is designed and adapted to ensure they are accessible for wheelchair users and drivers are expected to help their passengers when and where necessary.

"There is no excuse for not accepting a disabled passenger and we would urge other people who feel they have been discriminated against in this way to make a note of the vehicle registration number and contact the council Tel: **0161 234 5004.**"

A visually impaired woman, Annie Giles-Quinn, whose guide dog has repeatedly been banned from cabs, shops and restaurants, has launched a 'one-woman crusade' to highlight her situation.



Under the Equalities Act 2010, visually impaired people cannot be refused access or service, or given substandard access or service, because they have a guide dog.

She described how, on one humiliating occasion last summer, three cab drivers refused to take her because of her guide dog. But when it happened again in March, she decided to take action and complained to the licensing department.

Councillor Nigel Murphy, Manchester council's executive member for the environment, said: "It is the duty of every private hire and hackney carriage driver to allow guide dogs or hearing dogs into their cars".

## **Taxi Fares Increase Across Greater Manchester**

There has been an increase in Black Cab fares in 3 districts of Greater Manchester – Stockport, Manchester and Wigan.

Oldham has agreed a new fare structure, and drivers in Trafford and Tameside are also consulting on a rise.

A Manchester council spokesman said: "The fares have increased to reflect large increases in the cost of vehicle insurance and fuel".

## **Save Time... Get A Haircut...**

A disabled woman from London says she was told to "cut her hair" to save her carer time when she raised



concerns about her home care hours being cut.

Mary Garland had her home care hours reduced when Westminster Council changed its eligibility criteria. When she asked her social care manager how there would be time for her home carer to help her dress and wash, as well as clean, tidy and perform other home duties; she said the manager recommended she would be “better off cutting her hair”.

When Ms Garland asked what would happen if her condition worsened, she was shocked to hear the manager reveal she would have to go into residential care. She said the reduction in hours of home carer visits has affected many aspects of her life.

Westminster Council said it was unable to comment on the specifics of the case but Councillor, Rachael Robathan said: “Westminster Council is firmly committed to providing the

highest quality care to its vulnerable residents, treating our home care recipients with the utmost dignity and respect”.

“We are focused on protecting frontline services for those most in need, and strive to support disabled and older people at home for as long as possible before considering options for residential care.”

## **Lord Jack Ashley**

Lord Ashley of Stoke, the country's first deaf MP has died aged 89. Jack Ashley, who was a former Labour MP for Stoke-on-Trent, represented the city for 26 years until he was made a peer in 1992.



Lord Ashley was a tireless campaigner on a wide range of disability and social issues. His Civil Rights Bill (Disabled Persons) in 1983, was the first piece of anti-discrimination legislation presented to the UK Parliament. As a private member's bill, without the support of the government it was unsuccessful.

In the House of Lords, he initiated many debates on disability rights and fought against aspects of government

legislation that he felt were detrimental to disabled people.

The Co-chairs of the All-Party Parliamentary Disability Group in a statement said “Jack Ashley was an outstanding parliamentarian and champion of disability and human rights.

## Care Quality Commission Report

A review on  
Health Care for  
Disabled



Children published recently by the Care Quality Commission found that disabled children sometimes wait for up to a year for aids such as wheelchairs. It found there were considerable variations in services provided in England with the national average wait for a powered wheelchair being three months.

The survey also showed that the average wait for a referral to a community occupational therapist was 15 weeks, with the wait ranging up to two years.

Public Health Minister Anne Milton, reacting to the report, said that long waits and frustration for many families

was unacceptable and the Government would take action.

## Right To Independent Living

A report published by the Joint Committee on Human Rights in March, warned of a “significant risk” that the government’s policies will breach the UN Convention on the Rights of Persons with Disabilities.



It also found that the government’s welfare reforms and cuts to disability benefits and services are putting disabled people’s right to independent living at risk.

The inquiry's report is based on evidence given by many disabled people and their organisations; and recommends incorporating a right to

independent living and to advocacy in legislation.

It exposes the way the current government's welfare reforms mark a step backwards for disabled people and could force many into residential care.

## **Your Information Your Right**

Many organisations hold files on the people they deal with or have dealt with in the past; these include medical, social work, housing and school records. The Data Protection Act gives you the right to know what information is held about you.

If you want to see what is written about you, then you need to write to the organization you believe holds the information. If you are not sure who to write to, address your letter to the Company Secretary of the organization.

It is a good idea to send the letter recorded delivery. Keep a copy of the letter and any further letters you send or receive. The organisation may ask for a fee, which is usually no more than £10. Once the organisation has all the information it needs (which may include photo ID) and the fee, it must reply within 40 days.

## **PIP Consultation Until June 2012**

Disability Living Allowance (DLA) is being reformed to create a new benefit called Personal Independence Payment; initially this will be introduced for disabled people aged 16-64.

The Government has announced that Personal Independence Payment will be phased-in starting with new claims from April 2013. They will begin to reassess existing DLA claimants, starting in October 2013.

The consultation asks for views on a number of aspects of the regulations including eligibility to the benefit and payment of the benefit for certain groups. It also contains more details on how they will reassess DLA recipients.

The consultation will run until 30th June and the current intention is that the final draft of the regulations will be published by the end of this year. Further information about Personal Independence Payment is available on the DWP website:

## Work Capability Assessment

Paul Farmer, the Chief Executive of Mind has resigned from his position as the charity representative on the scrutiny panel set up to monitor the Work Capability Assessment.



He said his position was “no longer tenable” and that the Government was refusing to listen to criticisms of the Work Capability Assessment. He highlighted statistics showing around 50% of appeals that are heard against WCA decisions are upheld.

Whilst Farmer's decision has been widely supported by fellow mental health campaigners, ministers were less impressed. Chris Grayling, the Employment Minister, told the BBC that he had asked officials to ask Paul Farmer to step down after his charity, Mind, had begun legal proceedings against the Department of Works and Pensions. Mind stresses that the charity is not at this stage supporting any such legal action.

## **Schools Out**

Schools Out is a new GMCDP project for disabled children and young people aged 10 to 14 who live in Manchester.

It aims to give young disabled people the same choices and opportunities as their non disabled peers, for instance accessing local youth clubs, sports/school clubs and leisure activities.

The project will offer one to one support and advocacy, an information and signposting service for disabled people and their families, travel training, as well as group sessions during school holidays.

The project is funded by Manchester Children's Services for one year and there is no charge to any young person accessing the project.

**Grants For Home Security In  
Stockport**

The Home Security Package is a scheme which can help people in Stockport make their home more secure. To be eligible for the service, for which there is no charge, you will need to qualify for the Council's grant. This is available subject to funding if you are over 60 years old (or under 60 and receive an income related benefit) and you are a homeowner or a private tenant living in a house in Council Tax Band A-D.

The Council's Home Security Officer will visit your home to see which measures would be suitable. There is a range of measures available including:

- Door viewer or door viewer/intercom.
- Window locks.
- Door chain.
- Five lever mortise locks to external doors.
- Security lighting for properties with an open aspect.
