Cabbie Could Lose His Licence

A taxi driver may lose his taxi licence. He refused to take Brian Gaskell because he was a wheelchair user. Brian complained to Manchester council.



The driver was found guilty of a 'refusal to hire' charge at Manchester magistrates court. The driver will also have to go to a meeting to see if he can carry on being a taxi driver.

Councillor Nigel Murphy said:

Every licensed black cab in Manchester is accessible for wheelchair users.

Drivers are expected to help passengers when needed.

There is no reason to refuse a disabled passenger. People who feel they have been treated badly (discriminated against) should take the license number of the taxi. Then ring the council on 0161 234 5004 to tell us.

Also...

A visually impaired woman has started campaigning. Her guide dog has been banned from some taxis and cafes. The Equalities Act (2010) says that visually impaired people with a guide dog cannot be told they cannot go somewhere or have a service. They cannot be given a poorer service.

Last summer 3 taxi drivers would not take Ms Quin and her guide dog. And it happened again in March this year.

Councillor Nigel Murphy, Manchester council's executive member for the environment, said: Every private hire and hackney carriage driver must allow guide dogs or hearing dogs into their cars. Drivers must also make sure they do not treat disabled people poorly.

Taxi Fares Go Up In Greater Manchester

In Manchester, Stockport and Wigan it now costs more to use black cabs.

It may start costing more in Oldham, Tameside and Trafford as well.

A disabled woman from London says she was told to "cut her hair" to save her carer time. Mary Garland had her home care hours cut.

Mary asked her social care manager how her home care



carer would have time to do everything.

Mary said the Manager told her it would be better if she had her hair cut.

Mary asked what would happen if her condition got worse.

The Manager said she may have to go in a residential home.

Mary was shocked by this.

Your Information Your Right

Some places keep records about people. For example: Social Services, housing organisations, doctors, hospitals, colleges, schools. The Data Protection Act says you can find out what information is kept about you.

What to do if you want to see what is written about you:

- Write to the organisation you think has information about you.
- If you do not know who to write to, send your letter to the Company Secretary of the organisation.
- It is a good idea to send the letter recorded delivery.
- Keep a copy of the letter and any more letters you send.
- Keep a copy of letters you are sent from the organisation.

The organisation may ask for money (a fee). It is usually no more than £10.

Once the organisation has all the information it needs about you and any money they ask for, the organisation should send you the information by 40 days after you have sent them any money they ask or any information they ask for. They may ask for identification with a photo on it.

Care Quality Commission Report

The Care Quality Commission have written about health care for disabled children.



The report says:

Disabled children sometimes wait for up to a year for aids. For example, wheelchairs.

There are big differences in what services children can have around England.

Most children have to wait 3 months for a power wheelchair.

Most children wait 15 weeks to see a community occupational therapist. But some children waited 2 years.

Grants For Home Security In Stockport

The Home Security Package helps people in Stockport make their home safer (more secure).

It is a free service.

You need to apply for a grant from the Council. To get the grant you need to:

Be over 60 years old. Or be under 60 and receive an income related benefit.

Own your own home or be a tenant of a private landlord.

Be in Council Tax Band A-D.

The Council's Home Security Officer will visit your home to see what is best for you. Some of the things can be done are:

• A small glass to see out of the door (door viewer) or door viewer/intercom.

- Window locks.
- Door chain.
- Five lever mortise locks to outside doors.
- Security lighting for homes which have a lot of space outside.

Right To Independent Living

The Joint Committee on Human Rights have written a report. The report says the government's policies may go against the UN Convention on the Rights of Persons with Disabilities.



The UN Convention says what rights disabled people should have.

It says changes to benefits and cuts in services mean disabled people may not be able to live independently.

The report says this because of what lots of disabled people and disabled people's groups have said.

The report says there should be a law giving disabled people a right to independent living and advocacy.

The report shows that things are getting worse for disabled people.

The report shows that some disabled people may have to live in residential homes now.

Asking What You Think About Personal Independent Payment

Disability Living Allowance (DLA) is changing to Personal Independence Payment.

The change will start for disabled people aged 16-64.

People who apply from April 2013 will apply for Personal Independence Payment not Disability Living Allowance.

In October 2013 the Government will start asking people who are on Disability Living Allowance to have a new assessment for Personal Independent Payment.

Lord Jack Ashley

Lord Ashley of Stoke has died aged 89. Jack Ashley was the first Deaf MP. For 26 years he was a Labour MP for Stoke-on-Trent. Then he was made a peer in 1992.

Lord Ashley campaigned on many disability and social issues. His Civil



Rights (Disabled Persons) Bill in 1983 was the first time someone had asked for a law to stop people discriminating against disabled people. (Discriminating is treating someone badly).

In the House of Lords Jack Ashley started discussions about things important to disabled people. Jack Ashley spoke against laws he thought were not good for disabled people.

The Co-chairs of the All-Party Parliamentary Disability Group in a statement said "Jack Ashley was an outstanding parliamentarian and champion of disability and human rights".
